Privacy Policy

Introduction

Mint Luxury Linens ("Company" or "We") respect your privacy and are committed to protecting it through our compliance with this Privacy Policy ("Policy").

This Policy describes how We collect, use, share or otherwise process information relating to individuals ("Personal Information"). We are responsible for the processing of your Personal Information as described in this Policy, unless specified otherwise, and act as the controller of such Personal Information.

1. Processing activities covered

This policy applies to the processing of Personal Information we collect when you:

- Visit the website {www.mllinens.com} (our "Website");
- Visit our branded social media pages;
- Receive communications from us or otherwise communicate with us, including but not limited to emails, phone calls, texts, and other electronic messages;
- Download mobile and desktop applications from this Website, provided such applications are provided by us and not by a third party (in which case the privacy notice of the third party would apply);
- Interact with our advertising and applications on third-party websites and services, if those applications or advertising include links to this policy;
- Register for, attend, or take part in our events, webinars, programs, or contests;
- Act as or work for one of our service providers or suppliers, to the extent We act as a controller with respect to your Personal Information;
- Participate in surveys, research, or other similar data collection facilitated by us.

This Policy does *not* apply to Personal Information collected by Us or provided by our partners from:

- Publicly available information that you have published or that has been made available online;
- Through any other means, including on any other website operated by Company or any third party; or
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your Personal Information and how we process it. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using this Website, you agree to this Policy and the accompanying Terms of Use. This Policy may change from time to time (see Changes to Our Privacy Policy). 2. Personal Information We Collect About You and How We Collect It a. Personal Information We collect from you

The Personal Information we collect may include:

If you provide us with Personal Information relating to other individuals, you represent that you have the authority to do so, and where required, have obtained the necessary consent, and acknowledge that it may be used in accordance with this Policy. If you believe that your Personal Information has been provided to us improperly, or want to exercise your rights relating to your Personal Information, please contact us by using the information in section **Your rights** related to your Personal Information.

We may collect Personal Information from third parties, for example, our business partners. Please note, once you leave our store's website or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy or this Website's Terms of Service.

3. Shopify

This Website is hosted on Shopify Inc. ("Shopify"). They provide us with the online e-commerce platform that allows us to sell our products and services to you. Your data is stored through Shopify's data storage, databases, and the general Shopify application. They store your data on a secure server behind a firewall. 4. Children Under the Age of 16

Our Website is not intended for children. We do not knowingly collect Personal Information from (i) children under the age of 13 and (ii) from children between 13-18 unless we have obtained consent from a parent or a guardian or such collection is subject to a separate agreement with us or the visit by a child is unsolicited or incidental. If you are a child under 18, do not use or provide any information on this Website or on or through any of its features. If you believe we have mistakenly or unintentionally collected or received Personal Information of a

minor without verification of parental consent, we will take steps to delete their Personal Information from our systems.

5. Information We Collect Through Automatic Data Collection Technologies.

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The information we collect automatically may include personal information, or we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our Website according to your individual interests.
- Speed up your searches.
- Recognize you when you return to our Website.
 - The technologies we use for this automatic data collection may include:

10. Do Not Track

11. Residents of the European Economic Area (EEA)

14. Your rights related to Your Personal Information

You have certain rights relating to your Personal Information, subject to local data protection laws. Depending on the applicable laws, these rights may include the right to access, correct, or delete any Personal Information that you have provided to us. We cannot delete your personal information except by also deleting your user account. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.
